**APPOINTMENT:** Makeup Session / Bride 90 minutes. Makeup Session for additional clients 60 minutes. 20 minutes in-between sessions required. Fees: Bride \$50 dollars per session. Additional Clients \$50 dollars per session each. Parties over 6 will be \$45 dollars each. Kenz has the right to photograph the client to update her online and physical portfolio. Airbrush makeup is for Waupaca clients *only*.

**CONSULTATIONS:** Consultations (a “practice round”) are available for brides as well as their bridal party members. \$40 dollars each. Parties over 6 will be \$35 dollars each.

**TRAVEL FEES:** Travel within 10 miles of Waupaca, Wisconsin is completely free of charge. A mileage fee (\$0.50/mile both ways) will be charged for locations outside of the 10-mile radius of Waupaca, Wisconsin 54981. Travel fees apply for all pre-event makeup consultations as well as day-of appointments. *Travel fee can be adjusted September-May to/from Green Bay, at the bride’s convenience.*

**LIABILITY:** All brushes, tools, and makeup products are sanitized between every makeup application. Makeup products used are hypoallergenic. Any allergies and/or skin conditions should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client(s) agree to release the makeup artist (Kenz) from liability for any skin complications due to allergic reactions.

**PAYMENT:** The final payment is due two weeks prior to the day of the event. No exceptions. The person(s) responsible for the complete payment is the person(s) whose name(s) appear on this contract. If amount is not paid by the due date, your appointment will be cancelled. No exceptions.

**CANCELLATION POLICY:** Cancellations must be made at fourteen (14) days prior to the client’s reserved date or the client will be responsible for paying the full amount of services agreed upon in this contract.
